- F.** Exhibitor agrees to hold Expo USA Int'l Inc. harmless from any claims arising from Exhibitor's participation in the show, including claims arising from the use of Vehicles or equipment, move-in, move-out operations, but not limited to these activities, and from any claims arising from any act or omission of Exhibitor, its owners, employees, agents, or servants, and from any claim arising from loss, robbery, burglary, pilferage, fire, water damage, accident negligence or other cause, regardless of whose act or omission may generate such claim or claims.
